News from the Helm

A summary of matters arising from the TIBC Committee meeting held on the 13th November 2021.

Financial Report:

Dave Wade tabled the draft financial statements for the year to date ended 31st October 2021. Year to date Income is \$17,895 which is down \$2,737 (13%) on the same period last year. Membership income was down \$470 on last year; Advertising income is down \$735 and Bank Interest is down \$2,951 on last year. Donations however are up \$511 on last year. Total YTD Gross profit is \$15,545 compared with \$18,123 last year.

Total YTD expenses are \$10,352 which is \$3,512 higher compared than last year. The biggest variance here is due to increased expenditure on Ramps and Jetties Maintenance (+\$3,573).

The cash position remains strong at the end of October with a total of \$124,910 in cash across the various club accounts compared to \$118,650 at same time last year. We have \$119,618 on term deposit with SBS bank earning modest interest.

The YTD surplus is \$5,193 compared with \$11,282 the same period last year. This is mostly due reduced revenue and increased expenditure on Ramp and Jetty Maintenance and Repairs.

Total assets at end of October 2021 are \$127,396 ceed is to be made by 3rd December i compared with \$122,051 (+4.4%) at the end of October 2020. **Website:** Domain name is up for rene

Liabilities at the end of October 2021 are \$2,160. Net Assets of the club at the end of October 2021 are \$125,236 v's \$120,042 (+4.3%) at the end of October 2020.

Health & Safety:

Reports tabled on Penzance and Duncan Bay slipway and wharf facilities.

- Replacement pile on Duncan Bay catwalk has been delayed due to the contractor being involved in urgent repair work around the Sounds. This has now been scheduled for next year.
- The swimming platform at Duncan Bay has lost a flotation tank and requires lifting and repair. The Penzance swimming platform also needs be lifted and checked. Both also need grab ropes to be attached.
- No other major issues noted but Working Bees to be organised during the year to continue maintenance.

General Business:

Newsletter: Discussion on content and format. Chris Siale wants all material by 3rd December 2021.

Duncan Bay Turning Bay progress: Fulton Hogan advised that they have completed their part of the contract.

Merchandise: Leanne gave an update on clothing styles and ordering procedures.

Picnic Day: Discussion on possible scenarios under COVID restrictions. Final decision whether to proceed is to be made by 3rd December in time for notification in the December Newsletter.

Website: Domain name is up for renewal. We are looking to refresh our website. Libby to investigate and report back to the next committee meeting.

Next meeting is the AGM on 27th December, 4pm at Vicky & Clare's in Duncan Bay.

RED: Picnic Day will not go ahead.





Duncan Bay Turning Area

In November, Fulton Hogan finished their work at the Duncan Bay turning area. Some further tidy up work needs to be done which will be undertaken in the New Year.

Nevertheless, that is great news. The work took much longer than expected due to wet weather, COVID lockdowns, flood damage elsewhere in Marlborough, and a change in strategy under the supervision of an engineer engaged by the Marlborough District Council.

In the end, the MDC paid around \$32,000 for the area to be excavated and compacted for drainage and a grid system to be installed to help stabilise the whole area after heavy rain when it is affected by springs.

The TIBC is extremely grateful to the MDC for funding and project managing the work and to DOC for their cooperation.

Hopefully, members and the general public will appreciate the improved turning bay area (and

remember not to use it as a parking area).

What's in the shed... This newsletter we feature "Holly R", a beautiful 14ft classic clinker



Originally built in Dunedin in the late 1920's as a twin station rowing dinghy, it was used as the early owner's main mode of transport around the Catlins area of South Otago.

Kauri planking using clinker type construction. The new stringers were installed in later years.

In the late 1930's "Holly R" was converted to a motorised vessel with the installation of a twin cylinder Stuart Turner engine. Initially it had a crank start but has now been converted to an electric start.





The "Holly R" is now owned by Dave Broadway in Penzance Bay who purchased her 3 years ago from the previous owner in Motueka where it had sat in a shed for ten years. The motor required a little bit of TLC but with the expert help of Leigh Potton she is once again in running order. Dave takes her out for the odd excursion so keep an eye out for her classic lines cruising the waters of Tennyson Inlet.



Safety at Sea

Are your life jackets up to scratch? Now is the time to be checking them!

Wear and tear can shorten your jacket's lifespan, which manufacturers say is usually up to 10 years. This section tells you how to look after your lifejacket and how to tell when you should throw it out and replace it. Kapok lifejackets are unsafe – check, destroy, replace

Kapok is unsafe - Used to fill lifejackets 30 years ago, we now know kapok can absorb water and cause wearers to sink.

Cotton straps rot over time - Even if a lifejacket is not used. In an emergency cotton straps can tear or break off. Lifejackets with either kapok filling or cotton straps should be destroyed and new jackets purchased.

Old lifejackets used in New Zealand may fail in an emergency. If you use an older lifejacket (10+ years old) - or have them onboard – Maritime NZ recommends:

Check your lifejacket, even if you think it's safe - An unsafe life jacket may look in perfect condition. NZ standards have moved on - We recommend that your life jacket meets the current New Zealand Standard NZS 5823: 2005.

More than 10 years old? Replace it. - Manufacturers say that lifejackets can last up to a decade, although it can be less depending on deterioration from age or usage. After 10 years, they usually need replacing.



- Pull the straps, hard. If any of them stretch or tear, do not use the lifejacket, destroy, and replace.
- Look for tears or cuts in the straps. If there are any, do not use the lifejacket. Destroy and replace.
- Check for tears, cuts, or punctures in the lifejacket. If there are any, do not use the lifejacket, destroy and replace.
- 4.Check if it floats.

Show Us Your...

Recently Brittany (Britt) Andrews was fishing in one of the local bays and caught a very large Red Gurnard (57cm). When Britt and her boyfriend searched to see how large Gurnard grow and what might be a record size, they found that NZ Sportsfishing record size https://www.fishingcomp.co.nz/hall-of-fame/ recorded in 2020 in New Plymouth was 55.5cm. Other reports of large gurnard found online also showed a 55cm gurnard caught in Kaikoura. So maybe, just maybe Britt has landed a record size fish here in Tennyson Inlet, we say claim it Britt! When queried about exactly where she caught the fish, Britt was understandably a little coy, and said "in the sea".

The Marlborough Sounds is closed for blue cod fishing from September 1 until 20 December.

This is to support the reproduction of blue cod by reducing disruption to spawning behaviour and reducing catch numbers.

During this closed season, you may transport blue cod from the Challenger East area into the Marlborough Sounds area as long as you can prove where the fish were taken from.

In the Challenger area, for fish in table 1, there is a combined daily limit of 20, per fisher. This means that you can have a combination of up to 20 of any of these fish in total. For example, you could have 19 kahawai and 1 red cod, or 10 kahawai and 10 red cod. As long as you have no more than 20 in total

You can have the fish in table 2 in addition to the maximum of 20 fish from table 1. For example, you could take 10 kahawai, 10 red cod, and 6 eels.
